## **BUSINESS**

- Chairperson Bob Turner opened the meeting at 4:03pm and thanked all those in attendance. Bob specifically welcomed Life Members Helen Brownlee AM, Lynn Parker and Jeff Cottrell and special guest Phil Jones (CEO of Paddle Australia). Bob also thanked his fellow Board Directors for their efforts over the past twelve months.
- 2. **Previous Minutes:** The minutes of the previous PNSW Annual General Meeting held on 11<sup>th</sup> November 2017 were accepted as a true and correct record *moved Mark Bretag, seconded Gary Rake, carried.*

The state peak body recorded a surplus of \$7,352 in 2018 (\$13,627 deficit in 2017). It was moved that the financial statements for the year ending 30 June 2018, the Directors' Report and the Independent Auditor's Statement thereon, be accepted Ross Fraser/ Peter McIntyre carried.
