BUSINESS

- 1. Chairperson Tony Hystek opened the meeting at 4:07pm and thanked all those in attendance.
- 2. Previous Minutes: The minutes of the previous PNSW Annual General Meeting held on 15th October 2016 were accepted as a true and correct record - moved Laura White, seconded Aniie Lees, carried.
- Business Arising: Nil.
- 2016/17 PNSW Annual Report: On behalf of the Board and Management, Tony Hystek formally presented the 2016/17 PNSW Annual Report. The Annual Report was accepted by the members -Bob Turner/ Lynn Parker - carried.
- 2016/17 Statement of Accounts: Board Director Ross Fraser presented the Audited Financial Accounts, which record net assets of \$211,707 as at 30 June 2017 emphasising PaddleNSW is in a sound financial position. The state peak body recorded a deficit of \$13,627 in 2017 (\$29,987 in 2016). Ross presented an overview of initiatives being introduced after three successive years of deficit. All members were in favour of such initiatives. In response to a question from Phil Geddes, Peter Tate explained the rationale behind direct membership and the reason why fees will be increased for direct members.
